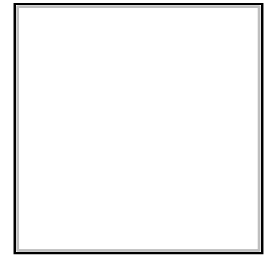

11 NOTES AND CONDITIONS RELATING TO NOMINATION AND SELECTION:

- A. The nomination form should be completed by the nominee in their own handwriting or typed on computer, but must be signed by a handwritten signature by the Angler and Provincial Chairman.
  - A1 If no fish are caught by an angler and/or team, the sections under 13; 17 & 18 must be filled in NP (No Points)
  - A2 Team and individual positions to be verified from Tournament Results to ensure no false information. If not sure, fill in NS (Not Sure). Tournament Results available from your Provincial Secretary.
  - A3 Latest Tournament Results to be used in section 13 Qualifying Tournaments with actual results. No "Not Sure" allowed.
  - A4 Latest Road to Protea 2023 version applicable (Especially relating to U19 -U21). Anglers to ensure they do qualify accordingly, before nominating.
  - A5 All anglers to be current to be able to nominate: must have fished in a SADSAA Interprovincial / All Coastal /All Inland / Nationals in the last 24 months prior to the closing date for nominations.
  - A6 SADSAA Skippers and Selectors also to be current: must also have taken part in the events as above (see latest Road to Protea Colours).
- B. No more information should be furnished than the space provided will allow for. Please do not add additional lines.
- C. No CV's or any other memos should be attached to the Nomination Form.
- D. Only fish caught strictly in accordance with IGFA Line Classes and Rules may be included in this form.
- E. Proof of payment of a non-refundable fee of R250 to SADSAA must accompany nomination. Juniors U19 don't pay nomination fees
- F. The completed Nomination Form shall be received by the SADSAA Admin Office on behalf of the Convenor: SADSAA Selection Panel no later than the close of business (5pm) on the closing date as notified to all Provinces.
- G. Successful nominees will be notified of the Selection Committee's decision by the President of SADSAA as soon as possible after selection has taken place, but under no circumstances will any further information concerning the selection be given to any person. Selectors may, however, advise anglers on how they may improve the chances of future selection if contacted.
- H. If you have any record fish to your credit or have been among the top individual anglers in any tournaments, details should be furnished in Section 9 of this form. Please do not duplicate information supply in section 13/17/18 of this form
- I. Each team member shall be personally liable for all costs and expenses directly or indirectly to the tournament.
- J. Captain duties and responsibilities when selected for a SADSAA or Protea Team
  - J1 To liaise with his team members with regards to the tournament
  - J2 To ensure all team members sign the Code of Conduct & Communications Policy and any other documentation required and return timeously to the SADSAA Secretary before leaving for the tournament.
  - J3 For Protea teams, to ensure that all team members complete and sign all SASCOC documentation and return timeously to the SADSAA Secretary.
  - J4 To confirm with SADSAA Administration the tournament entry fee in ZAR, and ensure each team member pays over their pro rata share to SADSAA within 30 days of Protea team announcements.
  - J5 To arrange bookings for accommodation, travel, and Forex. All relevant information relating to the tournament is obtainable from the SADSAA Tournaments Officer
  - J6 To ensure that the team has the correct clothing. Obtain all clothing requirements (sizes etc) to place one order with the recognised supplier of SADSAA or Protea clothing.
  - J7 To notify the team that no spouse, girlfriend or boyfriend may accompany the team (This is a SADSAA Council decision).
  - J8 On returning, to complete reports which cover the Tournament, the team positions and the anglers' behaviour, and to forward the same to the SADSAA email addresses on the reports.

J9 Collect all team members' medical information and emergency contact details.

- K. If we have problems in justifying the genuineness of international opponents, a SADSAA team will be selected, not a Protea team.
- L. If nominating for a Protea team, and the status of this team were to be changed, would you be willing to fish in a SADSAA or SASACC team, with the understanding that the sponsorship amounts from SADSAA differ. (Please tick the appropriate box)
